The following T&C sets forth the Terms & Conditions for NJ Gurukul Products and related matters thereof. These terms and conditions shall be applicable on purchase of any NJ Gurukul product. Your order for purchase constitutes your "offer" which shall be subject to the terms and conditions as listed below.

NJ Gurukul Pvt Ltd. may add to or change or update/revise these Terms & conditions and disclaimers, from time to time entirely at the its own discretion; without prior information to the Customers/members of the product/services of NJG.

# 1. DEFINITIONS

- "NJG" or "NJ Gurukul" means NJ Gurukul Pvt Ltd.
- "Product Order Form" or "POF" means the specific forms as published by NJG, either physical or online or in any other format, from time to time, for placing orders of the various NJG Products as identified therein.
- "T&C" shall mean these Terms & Conditions for NJG Products as provided by NJG and forming a part of the POF attached herewith.
- "Products" shall mean any goods/merchandise/products/services/offers/display items put up for sale by NJG for the Customers to place orders via online or offline modes.
- "The Customer" means the person eligible and authorized by NJG to request/order any NJG product, after reading and agreeing to this T&C.

#### PRODUCT PURCHASE

- The Product price covers the cost of text book, practice book, audio track pocket book, content and resources, CDs and DVD, printing and packing charges, shipping charges and is inclusive of all other taxes. All other incidental and related expenses, not specifically provided shall be borne and paid by the Customers.
- All products dispatched are duly screened to ensure that the products are of the requisite standard, quality, composition, style or model that they represent and as displayed on online desks or shown physically. However, it may have some variations with the design of the advertised product.
- Any request for cancellation of orders once duly placed, shall not be entertained.
- The product ordered by the Customer shall be dispatched at the address as specified by the Customer during placement of the order.
- Shipment/delivery time of order processing starts from the day of receipt of the payment confirmed against the order placed by the Customer. The Shipment/Dispatch time is 7 working days.
- In the event the product is not accepted by the Customer due to any defective/damaged products dispatched, then the same shall be replaced by the NJG at no extra cost to the concerned Customer subject to the availability of such product and adherence to the terms.
- All prices, unless indicated otherwise are in Indian Rupees. The availability of products is subject to change without prior notice at the sole discretion of NJG and orders can be cancelled if the product goes out of stock.
- NJG will not be liable for any credit card fraud because of the card being used fraudulently. The liability to use a credit/debit card or a net banking transaction fraudulently will be
  on the Customer and the onus to 'prove otherwise' shall be exclusively on the Customer.
- Neither NJG, nor any of its officers, group companies, directors, etc can be held responsible for any loss arising out of any transaction done in cash by any of the members or Customers or any other person.   which rules are deemed to be incorporated by reference into this clause. A sole arbitrator appointed by NJG shall conduct the arbitration. Notwithstanding the above, NJG or
  the Consultant shall be entitled to approach the court of appropriate jurisdiction for the grant of any interim or equitable relief.
- Governing Law: All acts under this T&C shall be governed by and construed in accordance with the laws of India, without regard to the laws regarding conflicts of law. Subject to
  arbitration, any litigation regarding this T&C or any action at law or in equity arising out of or relating to this T&C or any matter incidental or accidental thereto shall be filed only in
  the competent Courts of Surat(Gujarat) alone and the Consultant hereby agrees, consents and submits to the jurisdiction of such courts for the purpose of litigating any such
  action.
- If any provision of this T&C is held to be invalid, illegal, or unenforceable then such provision shall be enforced to the maximum extent permissible so as to affect the intent of this T&C, all other provisions will nevertheless continue in full force and effect.
